

***DOCTORS AND THERAPISTS AT REDEMPTION PSYCHIATRY DO NOT WORK WITH COURT RELATED COUNSELING, THEREFORE, IF THEY ARE SUBPOENAED TO APPEAR IN COURT MATTERS CHARGES WILL BE AS FOLLOWS:***

Attorney issuing the subpoena will contact the office, **at least 4 weeks in advance** of the court date, at Redemption Psychiatry, 2730 S. Val Vista Drive, Suite 146, Gilbert, AZ 85295 or 600 S. Dobson Road, Suite E-38, Chandler, AZ 85224 and block out

**A. 8:00 a.m. to 12:00 p.m.**

and/or

**B. 1:00 p.m. to 5:00 p.m.**

- "Standby" fees are billed at rate of **\$265.00** an hour, for any part of an hour. "Standby" is described as time doctor/therapist must wait for a telephonic appearance.
- Appearance fees are billed at court rate of **\$450.00** an hour, for any part of an hour.
- "Appearance" includes telephonic testimony, and/ or actual time in the court, or legal office building, or building where deposed.
- Deposition fees are billed at **\$650.00** per hour for the first four hours, for any part of an hour, and **\$450.00** for any part of every hour thereafter.

**Summary of other Court/legal related services are charged as follows:**

• Telephone Consultation	per 15 minutes	\$100.00
• Appearance/Court Testimony	per hour	\$450.00
• Record review, subpoena response, report writing	per hour	\$350.00
• Client/attorney or attorney staff consultation	per hour	\$450.00
• Deposition billed in 4 hour increments	per hour	\$650/450
• Conciliation consultation (parenting advisors, etc.)	not available	
• Therapeutic visitation (4 hours paid in advance) (Any part of an hour - no reimbursement if session is stopped)	not available	
• Travel time reimbursement rate (any part of hour)	per hour	\$200.00
• Mileage	per mile	\$2.00

***If Doctor/Therapist is subpoenaed without a four week advanced notice***, Attorney issuing the subpoena will be billed for all appointments that need to be rescheduled.

***Attorney issuing the subpoena*** will be responsible for payment of services in advance and any monies not used will be returned within 15 business days after the final judgment in the case.

***If court case is continued***, the doctor/therapist's office must be contacted **24 hours in advance** or the attorney issuing the subpoena will be charged for the previously blocked out four hour period.

Copies of progress notes are not released without a judge's order. However, the doctor or therapist will provide a written report and case summary with the appropriate signed consents, if so ordered by the court. As listed above, the report fee will be billed at the rate of **\$350.00** per hour, four hours to be paid in advance.
